3) School Management will be obeyed by all notifications of Education Deptt. of Punjab Govt. under RTE act 2009 and all rules of Punjab Govt. under RTE Act 2009.

4) After affiliation of CBSE New Delhi, School Management will be bound to pay the salary and all other benefits etc. through payee cheques to the school teaching and non-teaching staff as per schedule of Govt. Employees.

5) You and your Management be certain that if your District Education Officer or any other senior officer of education board may demand any information when and on any time, you would supply that information's with fully cooperation.
