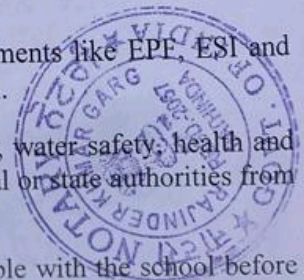

- 6) That the school will not open classes under CBSE pattern particular class IX,X,XI,XII and will not use CBSE name in any manner without obtaining affiliation.
- 7) That the principle and correspondent/ manager of the school having individually gone through the provision contain in the affiliation and examination by laws and the circular issued by the board from time to time the school undertake to avoid by the provision contain in the affiliation and examination by laws direction issued from time to time and the law of the land.
- 8) That the school will ensure compliance of all statuary requirements like EPE, ESI and labour laws etc. with respect to the school and staff of the school.
- 9) That the school will ensure that the building safety, fire safety, water safety, health and hygiene certificate and being issued by the concerned municipal or state authorities from time to time as per the prescribed terms.
